## Clinical Experience

### **Pediatric Neuro-Developmental Student Clinical Placement**

Worked jointly with health care professionals that included SLPs, OTs, SWs, pediatric neurologists, and pediatricians. Provided treatment to children with a broad range of conditions that included CP, Torticollis, Autism, Spina Bifida, Down Syndrome, Juvenile Arthritis, Hemophilia, and numerous others. Compiled detailed history from parents/guardians and assessed both physical functions and abilities of patients. Prepared customized treatment plans, executed treatment frequently with SLP/OT, provided home exercises and education, and participated in family/case management meetings.

- **Gained valuable experience in a short time period** through numerous activities and observations, starting off in SICU and learning extensively about acute care, x-rays, pre-op sessions, and chest/abdominal post surgeries. Attended CF clinic with CI 1x per week and viewed CABGx1 and AVR replacements.
- **Observed the respiratory team and worked with the cardiac rehabilitation team.** Followed patients with various cardiac-respiratory problems, including COPD, cancer, and acute illnesses. Aided patients with MSK issues. Viewed patients within MICU daily. Worked closely with families on cases

### **Outpatient Orthopedics Student Clinical Placement**

Assessed physical functions and limitations of patients with various musculoskeletal conditions. Developed patient-focused goals and implemented individualized treatment plans, setting up clients for classes as needed. Monitored patient progress frequently and evaluated effectiveness of interventions. Participated in orthopedic surgeons' clinics, with instructors analyzing need for x-rays, MRIs, further investigations, and other key matters. Viewed TKR and removal of external fixators on bilateral tibias post-op fracture/distraction to increase height.
